Topic: Church Property and Liability Insurance Decision

Discussion: Wesley McGregor gave a review of current coverage through Brotherhood Mutual. Discussion on coinsurance of 125% vs 100% vs 80%. Our premium of \$19,744.13 is due October 1st with current deductible increased from \$2500 to \$7500.

Action: The council asked Wesley to follow up on how selecting the 100% coinsurance would change the deductible and liability premiums. Also requested that he obtain a quote with Erie or other companies that Lightwell represents.

Topic: Goal Review and Accountability Conversation - Connor Williams

Discussion: The 120 Year Celebration was successful with 140 in attendance. Back to school supplies were delivered to Lone Oak schools. The Halloween Bash is planned for October 25th from 4pm to 6pm.
